1. Call to order: The meeting was called to order by Chair Boyd Frederick in the 2nd floor committee room at the Administration Building. Emily Bruno did roll call.

7. An Ordinance Amending MCKC Chapter 2: Joseph Cardamone explained the amendments. He immediately asked the Supervisors to move to strike the first change since it is too broad and can be dealt with on a single basis. **Supervisor Decker made a motion to strike the proposed change to 2.03 (2). Seconded by Supervisor Hallmon. YIG: both aye. All aye. Motion passes.**

Committee discussed the changes to 2.04 (2) (3). They agreed to not make motions to approve each individual change and to just vote on all of the changes as a whole.

Committee discussed changes to 2.05 (4) (a). **Supervisor Decker made a motion to strike recommended changes to 2.05 (4) (a) and leave language as it is. Seconded by Supervisor Skalitzky. YIG: both aye. Vote: Yes: 5; No: 2 (Franco and Frederick). Motion passes.**

Supervisor Hallmon made a motion to change “vice-chair” to “1st vice-chair” and change “secretary” to “2nd vice-chair.” Seconded by Supervisor Decker. YIG: both aye. All aye. Motion passes.
