Nina stated we are in year three (3) of the five (5) year grant. The SPSK projects helps noncustodial parents find employment so they can make reliable Child Support payments. If the participant is selected for the program they may be eligible for assistance with case management, job search, and employability and placement. Nina continued discussion on the SPSK program.
