Persons Who May Not Marry:

- Blood relatives – nearer of kin than second cousins, except when the female is 55 years of age or older.
- Persons declared incompetent by the Court.
- A person under the age of 16.
- A person who is divorced is prohibited from marrying until 6 months after the date the divorce was granted, as directed by WI §765.03(2).

Persons Who May Marry:

Every person who has attained the age of 18 years is of age to marry. If a person is 16 or 17 years of age, a license may be issued with the written consent of the person's parent(s), guardian or custodian. Parents, guardian or custodian consent forms must be executed at the time of application before the County Clerk or certified in writing and verified before a Notary Public.

Waiting Period: Upon making application, a 5-day waiting period is required by law. This is exclusive of the day of application. The license will be issued on the sixth day and is good for 30 days from the date of issuance.

When should you apply: No more than 35 days prior to the marriage date -no later than 7 days prior to the marriage date.

Witnesses: Two adult witnesses (18 years of age or older) are required for the ceremony in addition to the person officiating.

MARRIAGE APPLICATION REQUIREMENTS:

All requirements apply to BOTH applicants.

- Applicants must apply in person and together.
- **Valid Picture ID:** Male and Female. BOTH must show at the time of the application a Current un-expired State issued ID, Driver's License or Resident Alien ID.
- **Proof of Residency:** Current un-expired Driver's License, State ID, Resident Alien ID with current address or a current utility bill or government correspondence dated within 30-60 days ago, showing individual name and street address. Both applicants must show proof of where they reside.

Residents of the State must apply in the County in which either is a resident. They may be married in any County of the State.

Non-Residents of the State must apply in the County in which the marriage ceremony is to be performed. Proof of out-of-state residence must also be submitted.

- **Certified Birth Certificates:** Required from all applicants, regardless of age. Certified copies can be obtained from the County or State in which one was born. Photocopies, Registration of Birth Record or Hospital Souvenir records will not be accepted. Certified Birth Certificates in a foreign language must be translated into English by a third party and notarized. Translation must be done from the certified copy. Both the Certified Birth Certificate and notarized translation must be presented at the time of the application.
- **Social Security Numbers Are Required.**
- **Divorce Papers/or Certified Death Certificate:** If one or both of the applicants have been previously married, they must provide a copy of the Divorce Judgment with the court file stamped and judge's signature, Annulment papers or a Certified Death Certificate from their last marriage. If the marriage ended in divorce, it must be final for a minimum of six months whether the divorce was granted in Wisconsin or elsewhere.
- **Officiant:** Name, address and phone number of the person performing your wedding ceremony. Non-WI resident Marriage Officiant requires a sponsorship letter. A sample letter is available from the County Clerk's office upon request.
- **Courthouse Weddings:** The County Clerk's office will assist you in making arrangements for a Judge to perform your wedding at the Courthouse. The weddings at the Courthouse are scheduled for Monday-Friday around 11:30 a.m.

Who may apply for domestic partnership?

Applicants must meet the following requirements:

- The parties must be of the same sex.
- Both parties must be at least 18 yrs of age and must be competent.
- Neither party may be married.
- Neither party can be currently in a legal Wisconsin domestic partnership with another party.
- The parties must share a common residence.
- The parties cannot be closer in relationship than second cousins (even if they are related by adoption or by half-blood)(Wis. Stat. §770.05)

Waiting Period: Five days after the application is made, the County Clerk issues the Declaration of Domestic Partnership.

Is there a waiting period between a divorce or termination of domestic partnership and the application for the declaration of domestic partnership? *There is a 90 day waiting period between the termination of one domestic partnership and the application for another domestic partnership. There is no waiting period between the death of a domestic partner or death, divorce or annulment from a former spouse.*

Certified Copies: If the couple needs to show proof of the domestic partnership, they may purchase certified copies of the Declaration from the Register of Deeds or from the State Vital Records Office.

DOCUMENTS AND REQUIREMENTS TO APPLY FOR THE DECLARATION OF DOMESTIC PARTNERSHIP:

- **Applicants must apply in person and together.**
- **The individuals must be members of the same sex.**

Each applicant must bring in the following documents:

- **Certified copy of birth certificates.** Certified copies are issued by the State or County in which one is born. No photocopies, Notification of Registration of Birth Record or Hospital Souvenir Birth Record will be accepted. Certified Birth Certificates in a foreign language must be translated into English by a third party and notarized. Translation must be done from the certified copy. Both the Certified Birth Certificate and notarized translation must be presented at the time of the application.
- **Current (non-expired) Photo Identification.** State issued un-expired Driver's License, State ID or Resident Alien ID.
- **Proof of residency.** If the photo ID does not contain the current address, the applicant can bring in a dated utility bill or government correspondence if it is addressed to the applicant (by name) with the applicant's street address. At least one individual must show proof of residency in Kenosha County for at least 30 days prior to the application.
- **Proof of how last domestic partnership or marriage ended.** If an applicant was in a prior legal domestic partnership in Wisconsin or if an applicant was previously married, the applicant must supply documentary evidence of how the last legal domestic partnership or marriage ended. A certified death certificate, certificate of termination of domestic partnership or divorce judgment that shows the court file stamp & judge's signature.
- **Both individuals must provide Social Security Numbers.**
- **Five days after the application is made,** the County Clerk issues the Declaration to the partners. The partners complete the Declaration by signing it before the County Clerk, Deputy Clerk or a Notary. The partners file the completed Declaration with the Register of Deeds office. The domestic partnership does not go into effect until the date the Declaration is accepted and filed with the Register of Deeds office.
